NOTIFICATION

All the concerned are hereby informed that, pursuant to the recent verdict of the Hon. Supreme Court of India, dt. 28.08.2020 and in accordance with the guidelines of the University Grants Commission, dt. 06.08.2020 and in compliance with the directives of the Hon. Chancellor of the University and the subsequent decisions of the authorities of the University, namely; the Board of Examinations and Evaluation, the Academic Council and the Management Council, the Fresh and Repeater/ ATKT/ Backlog Examinations (Theory and Practical) of the Final Semester (In case of Semester Pattern Programmes/ Courses of Studies) and Final Year (In case of Annual Pattern Programmes/ Courses of Studies) as offered through Regular and Distance Education and the Repeater/ ATKT/ Backlog University Examinations of the other semesters or years of programmes/courses of studies (Regular and Distance Education) will be conducted as stated hereunder:

1. Examinations (Theory) of the students of the Final Semesters /Final Years and their ATKT/ Backlog examinations of earlier semesters/ years (i.e. Semester I, Semesters I to III, Semesters I to V, Semesters I to VII and Semesters I to IX of the Undergraduate Degree and Undergraduate Diploma Programmes/ Courses of Studies of one, two, three, four and five years' duration respectively) and the ATKT/Backlog examinations of Semester I, Semesters I to III, Semesters I to V in case of Post-Graduate Degree and Post-Graduate Diploma Programmes of one, two and three years' duration will be conducted by the University.

Provided, however that, in case of semester(s)/year(s) of various programmes/courses of studies, whose examinations are conducted by the Colleges/ University Departments on behalf of the University, the Repeater/ATKT/ Backlog Examinations of such semesters/ years will be conducted by the respective College/University Department in the month October 2020, ensuring that, no examinations either Fresh or Repeater are clashing on any dates of examination. And the pattern of such examinations will be similar to that of Fresh examination as stated herein below. The Colleges/ University Departments will upload on the University Portal, the marks obtained by the concerned students in the said examinations, as soon the examinations are over.

Provided, however that, the Fresh and Repeater/ ATKT/ Backlog Examinations of semesters I/II/III and IV of M.A. and M.Com. programmes offered by the Centre for Distance Education will be conducted by the University in the month of October 2020.

Provided that, the students (Regular and Distance Education) have duly filled the examination forms for Fresh and/or ATKT/Backlog examinations (Regular/ Distance Education), as the case may be, and paid the prescribed examination fee.

2. All Fresh and Repeater/ ATKT/ Backlog examinations as mentioned at Sr.No.1 will be held ONLINE and OFFLINE mode and the pattern of such examinations will be OBJECTIVE TYPE comprising 30(Thirty) MULTIPLE CHOICE QUESTIONS (MCQ), out of which, the student can attempt any 25 (Twenty-five) questions. The examination will carry 50 (fifty) marks and its duration will be one hour.

Provided, however that, the examinations which have weightage of less than 50 marks (e.g. 25, 35, 40 marks), such examinations will continue to carry the original weightage as prescribed by University. The question-papers of such examinations will carry same original weightage, e.g. 25, 35, 40 marks, as the case may be.

3. Students who do not have the necessary resources such as computer/ laptop/ Cell phone or Internet connectivity, etc. will appear for ONLINE examination at the respective College/ University Department, with prior intimation thereof well in advance, so that the necessary arrangements for the ONLINE examination can be made beforehand by such College/ University Department and such examination shall be subject to compliance of Covid-19 protocol of social distancing, sanitisation, wearing of masks, etc.
4. The practice sessions of the ONLINE examination will be made available to the students in the last week of September 2020.
5. The aforesaid Fresh and Repeater/ATKT/Backlog examinations will be tentatively held between 1st -15th October 2020. The detailed Time Table of the concerned examinations will be published by the University on its website shortly.
6. The Practical / Internship /Dissertation/ Viva Voce Examinations which could not be conducted due to the lockdown, will now be held between 10th – 20th September 2020. Such examinations will be organised ONLINE by the concerned College/ University Department, through Google meet, Microsoft Team, Zoom, WebEx, Telephone, etc. or other available modes and that, the complete recording of such examination will be maintained by the concerned Colleges/University Departments. The guidelines in respect of conduct of Practical Examinations/ Internship Evaluation/ submission of dissertations/ viva voce examinations have already been sent to all the concerned Colleges/ University Departments, vide University Circular No. Exam/BOD/Int.Diss /2020-21 dt. 02/06/2020. The marks obtained by the students in such examinations will be uploaded on the MKCL Portal by the concerned Colleges/ University Departments latest by September 30, 2020.
7. The concerned students be advised to check the University Portal (sndt.digitaluniversity.ac or www.sndt.ac.in) for further instructions and guidance, from time to time.

Students who cannot appear for ONLINE examination for certain reasons, may choose the OFFLINE mode of examination at the respective College/ University Department with prior intimation thereof to the College/ University Department concerned, well in advance, so that the necessary arrangements can be made by the College/ University Department beforehand. It shall be mandatory to comply with the Covid-19 protocol of social distancing, sanitisation, wearing of masks, etc. at the OFFLINE Examination venue. Such ONLINE and OFFLINE Examinations will be conducted simultaneously.
9. The facilities and concessions as admissible to the Divyang (physically challenged) students will be available at the time of both ONLINE and OFFLINE mode of examinations.
10. The results of the examinations of semesters/ years, other than the Final Semester/ Final Year of various programmes/ courses of studies, for the academic year 2019-20 (e.g. Sem. I in case of two years' duration programme, Sem. I and III in case of three years' duration programme, Sem. I, III and V in case of four years' duration programme and Sem. I, III, V and VII in case of five years' duration programme) which have been held in reserve for not clearing/passing the lower examination as illustrated herein, such students will be required to clear the lower examination(s) in the ensuing Repeater/ ATKT/ Backlog examinations to be held in October 2020. On clearing the lower examinations, the results which were held in reserve will be declared accordingly.
- Provided, however that, the results of the examinations of semesters/ years, other than the Final Semester/ Final Year of various programmes/ courses of studies for the academic year 2019-20 (e.g. Sem. I in case of two years' duration programme, Sem. I and III in case of three years' duration programme and Sem. I, III and V in case of four years' duration programme and Sem. I, III, V and VII in case of five years' duration programme) which have been held in reserve for NO APPEARANCE at the lower examination as illustrated herein above, such students will be required to clear the lower examination(s) in the ensuing Repeater/ ATKT/ Backlog Examinations to be held in October 2020. On clearing both lower examinations and internal assessment of the courses/ papers/ subjects of the current semester, the results which were held in reserve will be declared accordingly.
11. The students who have already filled the examinations forms for Fresh /Repeater /ATKT /Backlog examination(s) which were scheduled to be held in March/April 2020 and paid the prescribed examination fees will not be required to fill the examination forms or pay the examination fee for the examinations scheduled in October 2020.
12. The necessary guidelines and other related details on the conduct of ONLINE and OFFLINE examinations will be made available to all the concerned in due course of time.
